## WHAT IS OPEN ENROLLMENT?

This policy allows students to attend a public school other than their residentially-assigned district school. There are two types of open enrollment: Intradistrict refers to transfers within a child's home school district, while interdistrict refers to transfers outside of a child's home district.

<b>Universal Inter-District Open Enrollment</b> School districts are required to have an inter-district enrollment policy and accept transfer students, and are only permitted to reject transfer students for limited reasons, such as school capacity. <b>Universal Intra-District Open Enrollment</b> School districts are required to have an intra-district enrollment policy that allows students to transfer schools, and are only permitted to reject transfer requests for limited reasons, such as school capacity. Policies, including all applicable deadlines and application procedures, must be posted online on districts' websites.	Νο
<b>Transparent Reporting from the State Education Agency</b> The State Education Agency annually collects and publicly reports key open enrollment data by school district such as district transfer policies, transfer students accepted, transfer applications rejected, and reasons for rejections.	Νο
Public Schools Cannot Charge Tuition or Fees Districts are prohibited from charging families transfer tuition and/or fees.	Νο
Schools Districts are Required to Report Seating Capacity Districts are annually required to publicly report seating capacity by school and grade level.	Νο
<b>Transportation</b> Districts are permitted to bus transfer students across district boundaries without special permission, mileage caps, or other arrangements.	Νο
